APPLICATION FORM FOR NEW FIXED-WEIGHT COUNT PACKAGED FRESH PRODUCE UNIVERSAL PRODUCT CODE (UPC)

Please be sure you have thoroughly read this application form and attach the necessary documentation before sending it to the CPMA. APPLICATION FEES ARE NON-REFUNDABLE. Check with the CPMA before applying for a new code to make sure it does not already appear on the addendum and that there is not a similar code request pending.

Please allow sufficient time for the CPMA and the PEIB to assign new numbers. You should ALLOW AT LEAST 4 TO 6 WEEKS for CPMA to process this request. You should not wait until you are ready to print packaging to submit the application.

No application will be considered unless the following criteria are met and the proper documentation is attached. If any of these criteria are not relevant to the application, please indicate this on the form.

CRITERIA FOR NUMBER ASSIGNMENTS

1. COMMODITY

Product must be a fresh produce item sold in an unprocessed form (peeled and/or pre-cut produce is considered processed) through retail stores. Product must be sold in a fixed weight or count that carries the name and address of the shipper or packer.

2. VARIETY

Product must be a variety that is widely recognized (such as Apple, Red Delicious) as being distinct from another variety of the same commodity (such as Apple, Golden Delicious).

3. GRADE (IF REQUIRED)

Product must conform to an established grade of the Canadian Food Inspection Agency or other authoritative body and such grade must be recognized by the trade in its customary practices (e.g. Fancy). This criteria is used only where multiple grades of the same item need to be distinguished.

4. WEIGHT

Package weight must conform to a standard widely used throughout Canada. (e.g. 2lb. Carrots.)

5. SIZE

Product size must conform to standards widely used throughout Canada. (e.g. 2 3/8" Apple).

6. ORIGIN

A separate item number may be assigned to a product (Item A) that is similar in all respects to another product (Item B) that already has an assigned number if both the following criteria are met:

- Item A differs by being grown in an area whose products are regularly marketed as distinct and different from that of Item B.
- Item A is customarily assigned a separate stock keeping number (SKU) for inventory control by both wholesalers and retailers.

7. PACKAGING

A separate item number may be assigned to a product (Item C) that is similar in all respects above to another (Item D) that already has an assigned number if both the following criteria are met:

- Item C uses a type of packaging material that constitutes the principal differentiation for the trade to regularly market that item as distinct and different from item D.
- Item C is customarily assigned a separate stock keeping number (SKU) for inventory control by both wholesalers and retailers.

(For applications requiring more than 25 numbers, please call the CPMA for fees.) All fees will be payable at the time of application by the filing organization. Fees will be payable to the CPMA. The PEIB assumes no responsibility for return of filing fees once made, nor will such fees be refunded if an application is denied. All application fees will be payable to the CPMA at the time of application by the filing organization. Any and all applications will be made on forms available from the CPMA at www.cpma.ca or by contacting the CPMA offices. No other means of application will be accepted. While applications will be reviewed in a timely manner, the CPMA and the PEIB assumes no responsibility for any delay in reviewing any applicant's case. The application for new numbers can only be communicated to the CPMA in written form. Once a number is assigned, the CPMA will communicate it to the applicant.
